At the State Attorney's Office, Catie handled hundreds and hundreds of criminal cases including DUI,

For the past 20 years she has volunteered as a basketball coach for children and adults with Down Syndrome and Autism. She was involved with starting the program in 1999 with six children and over the past 20 years, has grown the program to over 40 participants.
